# Editorial

#### FEBC BEGINS A NEW CHAPTER

Far Eastern Bible College (FEBC) started a new chapter in her life and history when she reopened with a day of prayer on 5 January 2015. The Scheme to govern the sharing and use of the premises at 9, 9A and 10 Gilstead Road between Life Bible-Presbyterian Church (LBPC) and FEBC was finalised by the High Court on 27 November 2014. The law of charitable purpose trust which is of public interest has been established and applied.

The High Court of Singapore allotted to FEBC 1811.88 sqm of space for exclusive use (LBPC has 1999.72 sqm). With this, FEBC can now have a central library with increased shelf and study space. The library is located at the 2<sup>nd</sup> storey of the Extension Block near the dorms for easy and convenient access. The three classrooms at the 4<sup>th</sup> storey of the new Beulah Centre are used for our Hebrew, Greek, and English classes. Our offices, staffroom, and bookroom are moved to Beulah House (the house with a turret). There will be additional dorm space at the 2<sup>nd</sup> parsonage and 5<sup>th</sup> storey of the new Beulah Centre. Repairs and renovations which started at the end of last year are still ongoing. The old buildings at 9A especially need a lot of repairs. We hope to complete the necessary works in due time without disruption to the activities of FEBC and LBPC.

We pray for peaceful co-existence with LBPC for the sake of the gospel and the testimony of Jesus Christ. We believe the Bible is 100% inspired and preserved in the Traditional Hebrew and Received Greek Texts underlying the good old Authorised Version (KJV). This is according to God's power in history and God's promise in Scripture (Ps 12:6-7, Matt 5:18). This is true to the Westminster Standards and our Reformed Faith of *Sola Scriptura*—the sole, supreme and final authority of our faith and practice is in the infallible and inerrant *Apographa*, not just the *Autographa*. LBPC still uses the KJV. FEBC is defending the KJV.

#### Editorial

To be a faithful training institute for pastors and teachers, FEBC cannot but earnestly contend for the faith especially in these last days of doctrinal confusion and uncertainty (Jude 3).

This special edition of *The Burning Bush* is in thanksgiving to God for His miraculously inspired and preserved words of Holy Scripture and His marvellous protection of FEBC from those who sued to stop her from teaching a 100% perfect Bible without any mistake and evict her from her birthplace and home at Gilstead Road.

Indeed the words of the Lord are pure words "*purified seven times*" (Ps 12:6-7). The late Rev Dr Carl McIntire, founder of the 20<sup>th</sup> Century Reformation Movement and the International Council of Christian Churches (ICCC) and the Bible-Presbyterian Church (USA), taught the verbal and plenary preservation (VPP) of the Holy Scriptures. No matter what happens, one generation comes and another passes away, **God is going to preserve His words from one generation to another. The words of God will be preserved throughout all the generations**."

The false accusations of false teachers and bloggers in the social media notwithstanding, FEBC remains true to the good old Reformation Bible (KJV), the Reformed Faith, the Westminster Confession of Faith, and the Bible-Presbyterian Constitution and Statement of Faith to the glory of God and for the edification of His Church. Amen.

# THE TRUTH OF VERBAL PLENARY PRESERVATION

"Yea, hath God said?" were the first words of the serpent to Eve in the Garden of Eden. These words attack the perfect Word of God by casting doubt on them. The modern equivalent of these words is, "Can you really believe the Bible? It has mistakes, albeit very few and minor." Satan has attacked the Bible a doctrine at a time, from Ex-Nihilo Creation to the Global Flood, from the Virgin Birth to the Resurrection of Christ. Why this incessant attack? The reason is that without the perfect Word of God, there is no salvation. Without the perfect Word of God, babes in Christ cannot grow into spiritual maturity. Without the perfect Word of God, church leaders will not be able to defend the Faith. "Where there is no vision, the people perish: but he that keepeth the law, happy is he." (Prov 29:18). The "vision" and "law" here refer to the perfect Word of God. When the Word of God is obeyed, believers are happy, ie "blessed", which means that they have a personal salvific experience with Christ. When there is no perfect Word, the people die.

This old serpent is the devil himself. He knows the priceless value of the perfect Bible to all mankind. That is why he has not stopped attacking the Bible. In the past, Satan attacked its inspiration. When he failed, he started to attack its preservation. Instead of attacking the Bible writers, he is now attacking the Bible readers by spreading the lie that God has inspired His Word perfectly but did not preserve all of its words so that today Christians have a Bible with mistakes! This is the most deadly of all the attacks.

Bible attackers today claim to believe in the doctrine of inspiration, but they deny the doctrine of preservation. On the one hand, they say, "I am for the perfect Bible"; but in the next breath they say "the Bible has mistakes!" One hears such double talk from many professing believers. Did God inspire His Word without preserving it?

#### THE TRUTH OF VERBAL PLENARY PRESERVATION

To know the truth, we must start from the basics. What are the doctrines of biblical inspiration and preservation?

#### Verbal Plenary Inspiration and Verbal Plenary Preservation

Verbal" means "the words." "Plenary" means "all" or "complete." Verbal Plenary Inspiration (VPI) means "all the words are inspired." Verbal Plenary Preservation (VPP) means "all the words are preserved." The attackers of VPI and VPP both say that the Bible is perfect only in spiritual or doctrinal matters but contains mistakes when it comes to names, places, numbers, dates etc. They further say that the mistakes are minor. Sadly, just as this fallacious reasoning worked to deceive many, the same reasoning has succeeded in deceiving many in these last days. Hence, the terms VPI and VPP were coined to defend the absolute and total inerrancy and infallibility of the Bible from these attackers.

The Bible verses that teach the doctrine of inspiration are 2 Timothy 3:16, "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness." The phrase "given by inspiration of God" literally means "God-breathed." All Scripture is God-breathed. Inspiration applies to every jot and tittle of every word without distinction, and its grammar and syntax. It covers not just the Old Testament but also the New Testament. The whole and complete Bible is the very Word of God itself.

The Holy Spirit inspired God's servants to write all of Holy Scripture (Mark 12:36, Acts 1:16). The purpose for the giving of inspired Scripture is that "the man of God may be perfect, throughly furnished unto all good works." (2 Tim 3:17). This purpose always stands and has not changed. The Word of God is given for man's obedience and transformation. Without the perfect Word of God, man cannot be saved and be transformed. The inspired Word of God is indispensable.

The process of VPI is varied. In some instances, it is by dictation such as the entire book of Genesis, the Ten Commandments (Exod 20:3-17), the Civil Laws for Israel (Exod 21:1-23:33), the pattern of the Tabernacle and garments of the priests (Exod 25:1-31:18); and in other instances it is through eyewitness accounts or personal testimonies (Luke 1:2) and the Epistles. The writers of the Epistles clearly retained their

personalities. They were not robots or turned into machines. They wrote with their respective cognitive personal characteristics but the final product is altogether the words of God and not the words of men. The process may be varied but the end product is the same, ie the very perfect Word of God. The believers in the first century understood this very well. Paul wrote in 1 Thessalonians 2:13, "For this cause also thank we God without ceasing, because, when ye received the word of God which ye heard of us, ye received it not as the word of men, but as it is in truth, the word of God, which effectually worketh also in you that believe." The inspired Word of God effectually worked in the hearts and minds of all those who believed. It is important to note that the doctrine of inspiration applies to the words of Scripture and not the writers of Scripture.

The doctrine of VPI is not about a translation or version of the Bible. It is about the original language words. The languages that God used to inspire His perfect Word were Hebrew and Aramaic for the Old Testament (Dan 2:4b-7:28; Ezra 4:8-6:18; 7:12-26; and a few phrases in Aramaic in the Gospels) and Greek for the whole New Testament. VPI teaches that all the words in the original languages of Hebrew, Aramaic and Greek were Godbreathed words. Every word is perfect because the God who gave those words is perfect! Nevertheless, since the perfect Word of God is given for obedience, man must first understand God's truth. If man cannot read and understand God's truth, he cannot obey it. Hence, there is a need to translate God's Word.

The VPI doctrine is meaningless if the inspired books of the Bible are not identified. The 39 books of the Old Testament were already accepted as Holy Scripture by Christ and the Apostles. The Councils of Hippo (AD 393) and Carthage (AD 397) reaffirmed 27 books of the New Testament as Holy Scripture. Therefore all the 66 books of the Bible are inspired Scriptures. VPI means that all the words of these 66 books of the Bible were God-breathed, ie jot-and-tittle perfect!

There are more Bible verses teaching the doctrine of VPP than VPI. These are just a few of the verses to show that the God who inspired His holy and perfect Word also preserved all of it perfectly: Psalm 12:6-7, "The words of the LORD are pure words: as silver tried in a furnace of earth, purified seven times. Thou shalt keep them, O LORD, thou shalt preserve them from this generation for ever." Matthew 5:18, "For verily I say unto you, Till heaven and earth pass, one jot or one tittle shall in no

wise pass from the law, till all be fulfilled." Matthew 24:35, "Heaven and earth shall pass away, but my words shall not pass away." Mark 13:31, "Heaven and earth shall pass away: but my words shall not pass away." Luke 16:17, "And it is easier for heaven and earth to pass, than one tittle of the law to fail." Luke 21:33, "Heaven and earth shall pass away: but my words shall not pass away." Psalm 19:7, "The law of the LORD is perfect, converting the soul: the testimony of the LORD is sure, making wise the simple." James 1:25, "But whoso looketh into the perfect law of liberty, and continueth therein, he being not a forgetful hearer, but a doer of the work, this man shall be blessed in his deed." These Bible verses clearly teach the doctrine of VPP and the Bible's present perfection. The salvation and eternal life of every believer depends on the doctrine of VPP. Without the doctrine of VPP, every doctrine of the Bible comes under attack.

God gave numerous Bible verses to defend the doctrine of VPP because the attack on VPP is more deadly than the attack on VPI. God is perfect and His ways are also perfect. Indeed, we see this attack as more deadly and spurious because unlike the attack on VPI which came from the liberals and modernists, the attack on VPP comes from within the camp, ie from professing believers who claim to be conservatives. This makes their attack very potent and subtle. Personal relationships and financial considerations have muddied the waters so that the defence of the perfect Bible has become an emotional issue. The old serpent craftily blinded many by saying that this is a divisive doctrine that must be avoided and not allowed into the church. Foolishly, many church leaders say that they are neutral on the doctrine of the perfect Bible. Can a child of God be neutral on the doctrine of the perfect Bible?

VPI and VPP are the two sides of the same biblical coin. One cannot exist without the other. To believe in VPI is to believe in VPP, and vice versa. VPP means that God preserved the perfect Word of God the moment VPI started. VPP continues even after VPI stopped with the completion of the Book of Revelation. God gave His holy and perfect Word and God alone preserved it. Just as no one needs to know how inspiration was done in order to believe in VPI, no one needs to know how preservation works to believe in VPP. It is a matter of faith, like for all the doctrines of the Bible. God has declared in Hebrews 11:6, "But without faith it is impossible to please him: for he that cometh to God must believe that he is, and that he is a rewarder of them that diligently seek him." The perfect God who inspired all His perfect Words has also perfectly preserved every jot and tittle of all His perfect Words.

#### Verbal Plenary Preservation versus Textual Criticism

It is tragic that the opponents of VPP have to resort to distortions of this blessed and God-given doctrine to lend support to their attack on the perfect Bible. For example, it is fallacious to say that VPP is an argument from "textual criticism", which is the study of ancient manuscripts or copies in order to determine the author's intended meaning (See http://www .gotquestions.org/verbal-plenary-preservation.html). Textual criticism was invented by German Rationalists who denied and criticised the divine inspiration of the Bible. These were modernists and are not even believers. VPP is a doctrine totally independent of this evil approach to sacred Scriptures. Textual criticism is an invention of the devil. The ones who employ it to criticise the Bible have become victims of his deception. Get out of this snare of the devil. Stop using textual criticism! It is based upon man's pride and vanity. How can sinful man claim to "find" the truth when the basis of their find is on their claim that the autographs of all the inspired Scriptures are lost forever? Unless these men have the autographs, there is no way sinful man can "find" even one word of the Bible, not to mention all the words of the Bible. A man has a better chance of finding his wife's wedding ring that she dropped in the middle of the Indian Ocean than these foolish men in finding all the words of the Bible. These attackers of God's truth who resort to the caricatures of the blessed doctrine of VPP and then demolish it have fallen prey to the wiles of the old serpent!

Just as the VPI books of the Bible have to be identified or else the doctrine is meaningless, all the perfectly preserved words of the 66 books of the Bible have to be identified too. The nature of the doctrine of VPP demands that the preserved texts be in continuous usage or circulation throughout the ages. The texts were not hidden somewhere and then suddenly discovered. All the inspired words of God are found in divinely preserved manuscripts, namely the Ben Chayyim Hebrew Text for the Old Testament and the Greek Textus Receptus (Received Text) for the New Testament. In 1611, the King James Bible translators used them to produce a most faithful and accurate English version of the Bible. They recognised the Hebrew, Aramaic, and Greek words in those texts to be the very inspired and preserved words of God.

#### **King James Version**

The King James Version (KJV) is the most blessed English translation of the Bible. It is known as the KJV because for the first time in the history of the English Bible, the Bible was legally and publicly authorised by the King of England to be translated so as to unite a kingdom. Before that, there was a law across Roman Catholic Europe and England that made any unsanctioned translation of the Bible illegal and punishable by death. William Tyndale was the first man to translate the Bible into English from the original languages. For this, he was arrested and burned to death! The English translation of the Bible was key to the life and spread of Christianity. Of all the languages of the nations of the world, God used the English language as the foremost language to reach the world with His gospel and His truth. Today, the defence of the Christian faith as well as the attack is in the English language. To study and know the Bible in the original languages of Hebrew, Aramaic and Greek, the student has to know English. This was no accident.

By the providence of God, when the Apostle Paul wanted to go eastward toward Bithynia, the Lord told him to go westward toward Macedonia (Acts 16:7-9). By this one move, the gospel reached Europe and the gospel which began in Jerusalem was spread to the uttermost parts of the world through Europe. It was God's sovereign design to raise up Great Britain in the 18th century to rule 22.63% of the World and 20% of the world's population. God providentially caused Christianity and the English language to spread across the globe through Britain. Many countries today like America speak English. As such, Christianity in the English language also came under severe attack. This means that the Bible in the English language has also gone through the longest battle against the evil one. The longest attack has been on the English Bible. From the first translation in the 15<sup>th</sup> century till today, the attack has increased in momentum and ferocity. The reason for this attack is because English is the common language of the modern world today. Since the Bible is meant for obedience, and almost all believers in the world do not read Hebrew, Aramaic and Greek, the English translation of the Bible is all they will and can read.

When the KJV was completed in 1611, it was translated by the most spiritual believers of the time as well as the most academically qualified.

The best minds with the highest spirituality were assembled together to translate the Bible for the nation of England and for the entire Englishspeaking world. There will never be a gathering of such spiritual men of such learning again to do this God-honouring task. In the 19th century, French Naturalism, German Rationalism and English Deism, coupled with the birth of Darwin's Evolutionism, arose to assault the Christian faith like never before. The assault was so fierce and the damage so vast that no seminary or Bible college or church was left untouched. Through the influence of these anti-Christian philosophies, textual criticism was born. Man began to criticise the Bible from the authorship to the very words of the Bible. Seminaries and Bible colleges were all contaminated by the evils of textual criticism. The basic assumption is that the Bible is lost or not preserved and now it is up to man to find the words of the Bible. All sorts of arbitrary assumptions were concocted as the basis for textual criticism. The amazing thing is that many fundamentalist seminaries and Bible colleges are duped into teaching this evil, thus polluting future generations of seminary professors and pastors. Most if not all of the scholars who teach in the major seminaries and Bible colleges today are sold to textual criticism. It is no wonder that the standard of biblical and theological excellence continues to decline with the passing of every generation. How true is the warning from the Apostle Paul that Christians do not wrestle against flesh and blood but against principalities, powers and rulers of darkness of the world (Eph 6:12).

#### **Other Versions**

The VPP doctrine teaches that all the inspired words of God are perfectly preserved by God Himself. As already stated, they are identified as the Hebrew Masoretic Text (MT) for the Old Testament and the Greek Textus Receptus (TR) for the New Testament. They are the traditional texts which have been kept pure throughout the ages. Insofar as the Greek text is concerned the TR underlies the KJV, while the Westcott and Hort text underlies the modern versions. The TR represents the majority of the 5000 plus manuscripts. The WH Text is in the minority.

Every translation is based upon a particular Hebrew and Greek Text as determined by the translators. It must be reiterated here that the doctrine of VPP is not about preserving a translation; it is about the preservation of all the inspired words of God in the original languages of Hebrew,

Aramaic and Greek. Before there was any translation, there was the Word of God only, in Hebrew, Aramaic and Greek. No two translations are exactly the same. When we compare the New Testament in the Chinese Union Version (CUV) and the KJV, there are differences like fewer verses and different meanings in the CUV. We cannot deny these differences. What do we do with these differences? This can be applied to all versions or translations. There are two responses to consider:

#### **There Is No Solution**

(1) <u>Ignore the differences.</u> To reject VPP is to be like the proverbial ostrich—pretend that all is well and ignore the differences. It denies reality to believe that the differences do not exist or do not matter.

(2) <u>"I don't know"</u>. There are those who reject the VPP and simply raise their hands in surrender and cry, "I don't know; all translations have mistakes because the inspired words are lost." They either do not read the Word of God at all since they do not know where God's inspired words are, or they do read the Word of God but they choose to deceive themselves and others since they actually know!

(3) <u>"Somewhere out there but don't know where"</u>. This group of anti-VPP proponents cry, "The Word of God is somewhere out there in the 5,000 plus manuscripts but we don't know precisely where." Like the proponents of "I don't know", they do not read the Word of God since they do not know where it is; if they do read, then they are also deceiving themselves and others with their double talk.

The contradiction in the above three views is that whenever the Word of God is read, the translation used has to be based upon either the minority texts of Westcott and Hort or Textus Receptus which is the traditional text. Whenever a believer reads the Bible, the version he uses is his choice of the original text. The only way to be consistent to their "I don't know" view is to not read any Bible at all! By not reading the Bible, he will not be forced to choose. The moment he picks up a Bible to read, he has to ask himself, "where are the inspired words of God?" He has to be sure of all the inspired words of God before he starts reading! But the rejection of VPP automatically forfeits him of this ability to know for sure and choose the right version.

#### **There Is a Solution**

(1) <u>Compare with the Hebrew and Greek texts.</u> If you read Hebrew and Greek, then compare the CUV or any other translation with the MT for the Old Testament and the TR for the New Testament just as we compare the KJV with the MT and TR;

(2) <u>Compare with the most accurate and faithful translation in</u> <u>another language.</u> But if you do not read Hebrew and Greek but you read English and another language, then compare your translation with the KJV which is the next best way to know the truth. The KJV is the most faithful and most accurate translation of the Bible in the English language. So if the Christian reads English and Chinese (the CUV), then he can compare the CUV against the KJV. If he does not read English, then he should compare his translation with the most faithful and accurate translation in another language that he knows. The Rev James Sun did his thesis on the differences between the CUV and KJV (in the New Testament only) and it has been published by FEBC. This is a helpful companion to the CUV until a more accurate Mandarin version is made available.

(3) <u>Use the KJV as the basis for comparison.</u> Some might see this as an unjust comparison or reduce this to a racial or language problem between English-speaking and Chinese-speaking Christians. This is not the case at all. It is about the truth and accuracy of Scriptures.

God called the apostle Paul to go west when he wanted to go east in Acts 16:7-9. Because of this turnaround, the gospel headed west into present-day Europe. By the providence of God, the gospel reached Europe first and then to China much later. When the gospel went to China and before the first Chinese translation was completed (Marshman's Version in 1822), the KJV had already been in existence for over 200 years. This means that the first Chinese convert who believed in Christ did not have a Chinese Bible to read; unless he could read English, in which case he would be reading the KJV or Hebrew MT and Greek TR. He had to wait for the first Chinese translation. It came out in portions before the entire Bible was translated into Chinese.

This is true of all translations including the English language. The first English convert did not have any Bible to read in his own language

until John Wycliffe translated the Bible into English in 1382, the first English translation in over 1,300 years. But it was translated from the Latin Vulgate because Wycliffe did not read Hebrew and Greek. All the errors in the Latin Vulgate were also found in that first English translation. But as an English-speaking Christian who needed to read the Bible, he had no choice but to read that translation. It was either that or no Bible at all! There was not even an alternative translation to compare with because it was against the law of Rome to translate the Bible (unless the Christian could read Hebrew and Greek). The Roman Church hated Wycliffe for what he did.

The English-speaking Christian then should not reject the Bible in the original languages (VPI/VPP) just because Wycliffe's translation is different from the Bible in the original languages. This is what some of the Chinese-speaking Christians today are doing when they find that the CUV is different from the MT and TR—they reject the doctrine of VPP! By this very rejection they cut off the very foundation for the Chinese and all other translations! There would be no basis for translating any perfect Bible and evaluating which version is the best and most accurate and faithful!

The next English translation was by William Tyndale. He translated the first English Bible from the original languages. He managed to complete the New Testament (1526) and portions of the Old Testament before he was captured and burnt at the stake. He was martyred for translating the Bible into the English language. The Christians of that time could read Tyndale's English translation but it was incomplete. Does that mean they should reject the rest of the Old Testament which Tyndale had not translated? Of course not! The best method is to use Tyndale's and Wycliffe's translations together, with priority given to Tyndale's because his was translated using the Bible in the original languages and from the inspired and preserved traditional texts (MT and TR).

In 1611, the KJV was completed. For the first time in the history of the Church, a king authorised the translation of the Bible into English to unite a nation. The best minds and people with the best qualifications and highest regard for the Word of God, and who realised that the faith of an entire nation depended on their translation, were appointed to do this God-appointed work. This was done by God's sovereign will before the contamination that is textual criticism and before liberal churchmen like Westcott and Hort came into the scene to confuse and

undermine our trust in God's perfect Word. The KJV translators did not do it for money but for God's glory! The modern translations of today are contaminated by liberalism and textual criticism. Therefore, all the modern translations of all languages are inferior to the KJV because they were all translated by inferior translators tainted by liberalism and textual criticism.

#### Conclusion

The doctrine of VPP is a doctrine for all believers, as is the doctrine of VPI. It is not a translation issue but a source issue. God has chosen Hebrew and Greek as His languages for the inspiration of His perfect words.

Believing in the perfect Bible is more than just preaching it or writing theologically sound articles that defend and teach it. It is to live out the Bible in our lives! The Bible is given for one purpose only - it is to be obeyed in its entirety, not some part of it but every jot and tittle of it.

Those who defend the doctrine of VPP but disobey the Bible by their carnal and ungodly lives are more deadly and dangerous than those who tell you outright that they believe the Bible has mistakes. This is because they creep into the fundamentalist camp and deceive others into thinking that they are on God's side by their words. But their true colours are hidden from the gullible ones. These deceivers are indeed wolves in sheep's clothing; they do more damage to the cause of Christ from the inside!

Be discerning, dear believers. It is not what a person says from the pulpit or writes on paper that makes him a defender of the doctrine of VPP or the perfect Bible. He should be obeying the Word of God and defending it by his life even as he teaches and writes. The Bible is given for obedience and not for man to defend on paper! "Behold, I set before you this day a blessing and a curse; A blessing, if ye obey the commandments of the LORD your God, which I command you this day: And a curse, if ye will not obey the commandments of the LORD your God, but turn aside out of the way which I command you this day, to go after other gods, which ye have not known." (Deut 11:26-28).

# THE BIBLE COLLEGE, THE HIGH COURT, AND THE CHARITABLE PURPOSE TRUST

#### Jeffrey Khoo

Did FEBC break the commandment in 1 Corinthians 6:1-8 in seeking a declaration from the High Court (Case No OS6/2009G) that she has the right to the premises at 9, 9A, and 10 Gilstead Road which be her birthplace and home since 1962?

The answer is no for the following reasons:

(1) The case between Life Bible-Presbyterian Church (LBPC) and Far Eastern Bible College (FEBC) had to do with public and not private property and funds. Gifts and offerings were given by believers or collected in churches to purchase the land and erect the buildings not just for LBPC, but also for FEBC. Since monies were given for the purpose of a Bible College, specifically FEBC, it is the duty of the directors and trustees of the College to protect the funds and ensure that they are used to accomplish the charitable purpose for which they have been given.

(2) The dispute over doctrine and property should ideally be resolved between LBPC and FEBC without going to court. FEBC had repeatedly asked for a face-to-face meeting in 2007/2008 to resolve this matter amicably but to no avail.

(3) LBPC insisted that FEBC had no legal rights whatsoever to the premises. LBPC also demanded an unconditional undertaking from FEBC not to preach or teach the Verbal Plenary Preservation of the Holy Scriptures if she wanted to use the premises. This was impossible because FEBC cannot disobey God and act contrary to His Word. Verbal Plenary Preservation is a biblical doctrine (Ps 12:6-7, Matt 5:18, 24:35), and FEBC can neither deny the faith nor compromise on doctrine. To deny the faith and compromise on doctrine is sin.

(4) Since FEBC refused to sign this undertaking, LBPC ordered FEBC to vacate the premises by 30 June 2008. FEBC was deemed a "trespasser". LBPC warned FEBC against advertising any of her classes and said that any attempt by FEBC to do so would be seen as an attempt by FEBC to instigate the public to trespass into LBPC's property.

(5) The new FEBC term was about to open in two weeks' time. It was not possible for FEBC to vacate as she had nowhere to go. Besides, Gilstead Road is FEBC's birthplace and home since 1962. LBPC started to knock out and change the locks of the FEBC hall and classrooms.

(6) FEBC acknowledged LBPC's right to use the premises, but LBPC denied FEBC any right. Pushed to the extreme, FEBC had no choice but to appeal to Caesar. The question of whether FEBC is also "owner" and has rights to the premises was a question of law. Romans 13:1-5 tells us that the government is a divine ordinance to maintain peace and order in a country, and to make sure its citizens are treated justly and fairly [See J O Buswell's article, "Government as a Divine Ordinance," in TLBPC Weekly, 20 July 2008]. Buswell said, "There are cases ... in which one is a steward of a property for his own dependents and for others, cases in which it would be wrong to allow great loss without a protest. ... Indeed with the intricacies of modern economic and social life, there are some disputes which require the expert authority of the secular courts." What does the law say about our rights to the land? Having sought legal advice, the FEBC directors realised they had to act according to their fiduciary duty to seek the consent of the Attorney-General to apply for a declaration from the High Court concerning FEBC's rights to 9, 9A and 10 Gilstead Road.

(7) While FEBC waited for the Attorney-General's consent, LBPC went ahead to carry out her threat to commence action against FEBC. On 15 September 2008, LBPC filed a lawsuit to evict FEBC from the land. On 8 October 2008, the Attorney-General gave FEBC consent to seek a declaration from the High Court with regard to her rights to the premises at 9, 9A and 10 Gilstead Road.

(8) So, did FEBC sin against God? In light of the circumstances, No! John Calvin himself was not against the need to go to court when the situation requires it; he is only against those who initiate a lawsuit in

order to do harm to their fellow brethren. Calvin, in his commentary on 1 Corinthians 6, wrote, **"Paul does not condemn here those who, by force of circumstances, must enter into legal proceedings before unbelieving judges, for instance anyone who is summoned to court; but he finds fault with those who, on their own responsibility, bring their brothers there, and do them injury, as it were, at the hands of unbelievers, when another remedy is available to them. It is therefore wrong to take the initiative in instituting proceedings against brothers in an unbelievers' court. It is in order, however, to come into court and conduct your case, if a charge is made against you." In the court proceedings, LBPC was the plaintiff and FEBC the defendant.** 

(9) Calvin also went on to say that a lawsuit is in and of itself not wrong if it is for a good and just cause, but believers must enter into a lawsuit not with a heart of hatred or vengeance but with a heart of love. He wrote, "Let us therefore remember that Paul does not disapprove of law-suits on the ground that it is wrong in itself to uphold a good case by having recourse to a magistrate, but because they are nearly always bound up with improper attitudes of mind, such as lack of self-control, desire for revenge, hostility, obstinacy and so on. ... If a Christian therefore wants to prosecute his rights in a court of law, without going against God, he must take special care not to come into court with any desire for revenge, any bad feeling, any anger, or in a word any poisonous thing. In all this love will be the best guide."

(10) FEBC had no choice but to defend her birthright, her birthplace and home. It was done out of love for God, His Word, and His people. FEBC affirms and upholds not just the past but also the present perfection of the Bible, and by the logic of faith, based on the twin doctrines of Verbal Plenary Inspiration and Verbal Plenary Preservation, identifies where the infallible and inerrant words of God are so that God's people might subject their faith and practice to the sole, supreme and final authority of a sure and certain Scripture which is readily available and easily accessible. Surely such a biblical conviction and confession is good for the Church and all Bible-believers (Ps 19:7-14).

(11) FEBC was duty bound to protect the beneficiaries of the charitable purpose trust. FEBC did not seek the eviction of LBPC, but LBPC sought to deprive FEBC of her heritage and home. The apex court

on 26 April 2011 judged that FEBC has rights to 9, 9A, and 10 Gilstead Road and declared that "the College, in adopting the VPP doctrine, has not deviated from the fundamental principles which guide and inform the work of the College right from its inception, and as expressed in the Westminster Confession... It is not inconsistent for a Christian who believes fully in the principles contained within the Westminster Confession (and the VPI doctrine) to also subscribe to the VPP doctrine." FEBC is vindicated.

(12) This whole process has brought about a healthy respect for the judiciary and the law. It is also a matter of public interest to know and understand what a charitable purpose trust is. All churches and charities should understand this principle of law. God can glorify His Name even in a secular court, because the secular court is an institution set up by Him.

"I will praise thee with my whole heart: before the gods will I sing praise unto thee. I will worship toward thy holy temple, and praise thy name for thy lovingkindness and for thy truth: for thou hast magnified thy word above all thy name. In the day when I cried thou answeredst me, and strengthenedst me with strength in my soul." (Ps 138:1-3).

# THE SCHEME FOR THE SHARED USAGE OF 9, 9A AND 10 GILSTEAD ROAD, SINGAPORE

1 This Scheme ("the Scheme") for the shared usage of Nos 9, 9A and 10 Gilstead Road, Singapore (collectively referred to as "the Premises") is hereby settled by the High Court of Singapore. The Parties to the Scheme are:

- (a) Life Bible-Presbyterian Church ("the Church"); and
- (b) Dr Jeffrey Khoo, Dr Quek Suan Yew, Dr Prabhudas Koshy, Dr Boaz Boon, Wee Hian Kok, Rev Koa Keng Woo and Rev Stephen Khoo; collectively an unincorporated association operating the Far Eastern Bible College ("the College").

# The Scheme is dated 27 November 2014.

# A. Background to the Scheme

2 The Court of Appeal has by a Supplementary Judgment dated 25 July 2012 ("the Supplementary Judgment"), attached hereto as Annex A, ordered that a High Court Judge draw up a scheme setting out the respective rights and obligations of the Parties in relation to the use, occupation, maintenance and upkeep of the Premises which have been impressed with a charitable purpose trust so as to:

- (a) equitably cater to the present and reasonably foreseeable future needs of the Church and the College without unfairly subordinating the interests of one institution to the interests of the other;
- (b) fairly apportion the obligation and responsibilities pertaining to the maintenance, upkeep and upgrading of the Premises between the Church and the College;

- (c) prevent or reduce the incidence of disputes concerning the use/ occupation and maintenance of the Premises; and
- (d) devise a resolution process to determine operational issues that may arise from time to time.

The Court of Appeal also directed that any division of the Premises should only be in terms of usage, not ownership, of the Premises. Any such division should not have regard to the amount of financial contributions made by each party to the acquisition and/or refurbishment of the Premises.

# **B.** General provisions

3 The purpose of the Scheme is to promote the harmonious shared use of the Premises. The Church and the College shall use their respective best efforts to co-operate with each other in the implementation of the Scheme.

4 The Party having exclusive use of any part of the Premises shall be primarily responsible to ensure that use and occupation of that part of the Premises shall be in compliance with all relevant laws, rules and regulations of the relevant authorities with regard to use of the same. If any Party receives notice or learns that there is or may be a breach of such laws, rules or regulations in respect of any part of the Premises exclusively occupied by the other, it shall immediately inform the other Party of such notice or information.

# C. Allotment and terms of use of the Premises

5 The Church and the College shall be allotted the parts of the Premises as described in Annexures B and C for their respective purposes and use pursuant to the charitable purpose trust. A description of the areas for exclusive use, shared use and common use is annexed hereto as "Annex B". A copy of the floor plans of the buildings on the Premises showing the respective allotment of the Premises for the Church and the College is annexed hereto as "Annex C".

6 The Party having use of any part of the Premises which are for

shared use must ensure that after its use of the same, that part is left in a clean condition ready and available for use by the other Party.

7 The Church and the College shall not be responsible to the other for any accident or incident by which injury is suffered or damage to or loss of any property is sustained by any one on any part of the Premises which at the relevant time is under the direct care and control of the other.

8 The Church and the College shall only use the Premises whether allotted for exclusive, shared or common use, in accordance with their purposes as church or bible college as the case may be and in compliance with all laws, rules and regulations of relevant authorities.

9 Neither Party shall carry out any additional or alteration works requiring the approval of the building authorities on any part of the Premises without the prior written consent of the other, which consent shall not be withheld if such works are necessary for the maintenance, upkeep or enhancement of the Premises and are supported by relevant professional and technical expertise to ensure proper planning and execution of the same. Works effected only for the purposes of repair shall not be regarded as additional or alteration works. All works shall be carried out in such manner as to minimise any interference with the other Party's use of the Premises,

10 Any unauthorised works installed on the Premises shall be removed forthwith by the Party responsible at its own cost if and when required by the other Party or by any relevant authority.

11 Neither party shall permit any other body to use the Premises at any time, whether for profit or otherwise, except with the written consent of the other.

12 The Parties may voluntarily agree to vary the allotted usage of the Premises from time to time. In this regard, a reputable licensed property manager shall be appointed to re-calculate the Parties' respective contributions to the General Maintenance Fund based on the principles of this Scheme.

# **D.** Obligations and responsibilities on the maintenance and upkeep of the Premises

13 13.1 The Church and the College shall each be responsible for the proper maintenance, upkeep, cleanliness, safety and security of the Premises allotted for their exclusive use.

13.2 As regards all parts of the Premises which are in shared or common use (eg, roofs, car parks and drains), the Parties shall have shared responsibility for maintaining those parts of the Premises.

14 The Parties shall appoint Messrs Jones Lang LaSalle ("JLL") to draw up a report addressing the proportions in which the Parties are to contribute towards the maintenance and upkeep for the parts of the Premises which are for common and shared use. The report shall show the percentage of usage according to the current situation (prior to this Scheme) and also for the situation when the Scheme is fully implemented and shall be issued together with the determinations pursuant to paragraph 21.

15 The Parties shall set up a General Maintenance Fund (the "GMF") in a joint bank account (the "GMF" Account) with an initial sum of \$20,000 for the regular general maintenance and upkeep of the Premises. The GMF Account shall be managed by joint signatories comprising one signatory each from the Church and the College (the "Signatories").

16 After the initial deposit into the GMF, as and when the amount in the GMF Account falls below \$10,000 the Church and the College shall upon written notification by any Signatory forthwith make further contributions to top up the GMF Account to \$20,000. Such contributions shall be in accordance with the proportions determined pursuant to cl 14.

17 In the event that urgent repairs and other non-regular works needed for the proper upkeep and maintenance of the Premises, which are shared or in common use, the Parties shall inform each other of the same and each be entitled to obtain appropriate quotations for any single expenditure above \$10,000 for the reasonable execution of such works. If the Parties cannot agree on the work to be done, the contractor of the same, they shall resolve their dispute in accordance with Section F. 18 If either Party shall fail to properly maintain the areas which are allotted for its exclusive use, the other Party may serve written notice to the Party in default to remedy or rectify the default within a reasonable time, failing which the dispute shall be resolved in accordance with Section F.

19 Without prejudice to any other provision of the Scheme, the Church and the College shall fully indemnify and hold each other harmless at all times from any loss, damage, injury, liability or claims whatsoever and howsoever arising from their respective breach of any term of the Scheme.

## E. Charges for utilities

20 Pending the full implementation of the terms found in paragraphs 21 to 24 below, the Church and the College shall contribute to the utility bills based on the proportions of their current usage as determined by JLL in paragraph 21.

21 JLL shall be appointed to determine which areas within the exclusive use of the Church and the College are suitable for the installation of separate utility meters. The findings are to be made within three months of the effective date of the Scheme and the Church and the College shall be bound by the determinations of JLL.

22 22.1 The Church and the College shall, within three months from the date on which JLL presents its determinations, install at their own expense utility meters for the areas that are allocated for their exclusive use so that the Church and the College may each be charged separately for utilities consumed on those parts of the Premises which are allocated for their respective exclusive use and occupation.

22.2 Utility meters for the areas that are to be shared by the Church and the College shall be installed during the same period so that the utility charges for these areas may be ascertained. The costs of installation shall come from the GMF.

23 Insofar as the separate metering facilities pursuant to paragraph 22 above enables the Church and the College to he charged separately for

utilities consumed on those parts of the premises respectively allocated for their exclusive use and occupation:

- (a) the Church shall he responsible for paying all utility charges incurred for those parts of the Premises allocated for its exclusive use and occupation; and
- (b) the College shall be responsible for paying all utility charges incurred for those parts of the Premises allocated for its exclusive use and occupation.

As regards charges for utilities consumed on (i) common property; (ii) those parts of the Premises that are to be shared by the Church and the College; and (iii) other parts of the Premises where separate metering is not possible to allow the Church and the College to be charged separately for utilities in the manner envisaged by paragraph 22 above, JLL shall be appointed to prepare a proposal as to how such charges for facilities should be shared between the Church and the College. Such proposal should take into account the respective use by the Church and the College of those parts of the Premises as provided for herein and the proposal made by JLL shall be binding upon the parties.

#### **F.** Dispute resolution

25 In the event the Church and the College are unable to agree on any matter pertaining to this Scheme, then without abating in performance of the respective obligations as prescribed under this Scheme, the Parties shall seek resolution of all such disputes through the following process:

- (a) The unresolved dispute shall be referred to the Singapore Mediation Centre for resolution by mediation in accordance with the Mediation Procedure for the time being in force. The Parties shall participate in the mediation in good faith.
- (b)In the event of failure to reach an amicable and mutual resolution through mediation, within one month of the same having been referred to mediation pursuant to sub-paragraph (a), the dispute shall be referred to and finally resolved by

an ad hoc arbitration before a single arbitrator appointed by the President of the Court of Arbitration of the Singapore international Arbitration Centre ("SIAC"). The arbitration shall be completed within three months from the date the Arbitrator is appointed.

## G. Transitional provisions

Any part of the Premises which are to be handed over to the other Party pursuant to the Scheme need not be reinstated but is to be handed over vacant in an "as is" condition.

The handing over of any part of the Premises from the Church to the College or vice versa shall be completed within six months from the date of the Scheme.

# H. Parties

This Scheme shall bind the Church and its successors and assigns and all individuals who for the time being comprise the unincorporated association operating the College.

July 30, 2013 FEBC's lawyers, Allen & Gledhill, filed FEBC's Defence arguing that (1) LBPC had earlier in their letter dated 28 January 2008 rejected FEBC's offer of a lump sum of \$200,000 for past utilities plus \$5,000 monthly and returned all cheques to FEBC and even told FEBC not to tender any further cheques as it was prepared to let FEBC occupy the Land free of charge for "this extended period", and that (2) what LBPC is attempting to do is an abuse of process for at no time in their 1st suit (High Court Suit 648) did LBPC make any claim against FEBC for unpaid contributions towards maintenance of the Land even though they could have done so (if they thought they had a valid claim).

August 11, 2013 FEBC released an article entitled "In the Interests of the Church" in the True Life BPC Weekly of 11 August 2013 which is a response to LBPC's "Pastoral Announcement" of 14 July 2014. In this response, FEBC highlighted LBPC's unbiblical act in suing fellow Christians for money in light of 1 Corinthians 6 which they themselves had acknowledged as something the Bible forbids in their Weekly of 13 July 2008. The article went on to give the context of LBPC's 1st lawsuit in 2008, explain the doctrine of Verbal Plenary Preservation (VPP), provide the historical context of the symbiotic relationship LBPC had with FEBC, and show how FEBC had contributed to LBPC in the past. The article also clarified, "Contrary to Life BPC's 'pastoral announcement', there was no indication from Life BPC that it intended to accept an 'amicable compromise'. The letters from Life BPC's lawyers dated 25 January 2013, 4 February 2013 and 12 March 2013 contained no unambiguous or amicable offer 'to accept the

sum previously tendered'. As a matter of fact, the letters were not written in the form of a request, but a demand coupled with threats of legal action. While there is no basis for Life BPC's demands, the FEBC Directors have attempted to resolve the matter amicably with Life BPC, but this has been rejected by Life BPC."

- August 13, 2013 LBPC replied to FEBC's Defence. In their reply, LBPC alleged or asserted the following: (1) FEBC is estopped from taking the position that the 1970 Agreement is not a legally binding contract because FEBC's claim in Suit 648 of 2008 was based on the 1970 Agreement being a legally binding contract, and the Court of Appeal had found in favour of FEBC on this basis, so the question of whether the 1970 Agreement is a legally binding contract is therefore also res judicata, ie it has already been decided by the Court, and cannot be revisited; (2) LBPC did not previously collect contributions from FEBC because it was under the misconception that FEBC was a ministry of LBPC; and (3) FEBC admitted in its letter 3 August 2007 that it had an obligation to contribute to maintenance and utilities.
- August 27, 2013 LBPC filed an amendment to their Statement of Claim on 27 August 2013. The amendment sought to include an additional clause of action that the Defendants are liable "to contribute a reasonable and/or equitable amount of monetary contribution to the maintenance, upkeep, and provision of utilities for the Premises for the period stated."
- September 20, 2013 Lee & Lee filed a Summons for Directions to fix a hearing before the Court to obtain its formal directions for the parties to prepare the case for trial. However, it was expected that the Court would refer the parties to alternative dispute resolution processes such as mediation.

- November 5, 2013 Notwithstanding legal advice that FEBC have strong grounds to resist LBPC's suit, the Board of Directors decided to exercise the law of charity based on Matthew 5:38-48 in order to resolve this dispute. FEBC sent to LBPC's Board of Elders on 5 November 2013 a letter with the heading, "The Higher Law of Christian Charity", offering to LBPC a love gift of \$350,000 in full and final settlement of any and all claims by LBPC up to the date of the Scheme that is to be established and implemented. FEBC believed that this charitable gesture glorifies God and is good for all.
- November 18, 2013 In a letter dated 18 November 2013, LBPC rejected our offer of \$350,000 saying that it was inadequate. They also said they were disappointed that FEBC had used religious language and cited Bible passages in its letter of offer. They demanded \$500,000 and a further \$5,000 per month as contributions hereafter for a full and final settlement.
- November 23, 2013 At the Summons for Directions hearing held on this date, the Court ordered the parties to mediate at the Primary Dispute Resolution Centre of the Subordinate Courts in January 2014 following the parties' agreement to mediate.
- January 23, 2014 Justice Judith Prakash visited 9, 9A, 10 Gilstead Road on 23 January 2014. Her site visit was necessary to the Scheme she would be drafting to regulate the sharing and use of the premises by LBPC and FEBC. LBPC's representatives were their Elders, Ng Beng Kiong, Tan Cheow Hock and Lee Heok Seng. FEBC's representatives were Jeffrey Khoo, Wee Hian Kok and Quek Suan Yew. Lawyers from both parties were also present.
- January 29, 2014 A mediation meeting was convened in the Primary Dispute Resolution Centre of the State Courts

(renamed from Subordinate Courts) on 29 January 2014. Jeffrey Khoo and Wee Hian Kok represented FEBC. Ng Beng Kiong and Lee Heok Seng represented LBPC. The mediators (both District Judges) were Ong Chin Rhu and Joyce Low. FEBC offered to pay \$250,000 on condition that LBPC cease from making any further demands and suing for more. LBPC refused. The mediators scheduled another meeting on 19 February 2014.

- February 19, 2014 The second mediation meeting was attended by Jeffrey Khoo, Wee Hian Kok, and Quek Suan Yew. LBPC was represented by Ng Beng Kiong and Lee Heok Seng. Lawyers from both sides were present. The two mediators were the same two District Judges, Ong Chin Rhu and Joyce Low. FEBC emphasised that LBPC's claim was without basis. Out of goodwill and charity, FEBC offered LBPC \$250,000 to settle. This time, on top of the \$250,000, FEBC was prepared to contribute \$5,000 monthly to utilities until the Scheme is implemented. LBPC rejected our offer. The mediators asked for one more meeting to be held on 6 March 2014.
- March 6, 2014 Jeffrey Khoo and Quek Suan Yew attended the third mediation meeting. Ng Beng Kiong and Lee Heok Seng represented LBPC. The mediators this time asked the lawyers to excuse themselves. The mediators expressed concern that charity funds are used for litigation. We told the mediators that FEBC had obtained the Attorney General's consent for the first suit in the High Court. LBPC on the other hand did not. We adhered to our previous offer on condition that LBPC recognise FEBC as a co-beneficiary and co-steward of the premises. LBPC rejected our offer. As no headway was made because of differing fundamentals and perspectives, the mediators terminated the mediation process.

#### THE BATTLE FOR THE BIBLE: CHRONOLOGY OF EVENTS II

- March 11, 2014 As mediation had not led to a settlement, the Court gave directions at the adjourned Summons for Directions hearing on 11 March 2014 regarding deadlines for the discovery of documents, the exchange of affidavits of evidence-in-chief of witnesses and the setting down for trial.
- June 12, 2014 Notice of Court was issued to the lawyers of both parties for trial to be held on 24 and 25 July 2014.
- July 24-25, 2014 DC Suit No 1956/2013 filed by LBPC against FEBC was heard before District Judge Seah Chi Ling. The plaintiff-LBPC-was represented by Mr Quek Mong Hua, Mr Nicholas Poa and Mr Jonathan Cho of Lee & Lee, and the defendant-FEBCwas represented by Mr Ang Cheng Hock (Senior Counsel), Mr Tham Wei Chern, and Mr Ramesh Kumar of Allen & Gledhill. The two-day trial ended with FEBC indicating it was ready to make a "no case to answer" submission after LBPC's close, but LBPC pleaded that its close was "mistakenly" Without deciding on whether LBPC's made. "mistaken" close could be retracted, the District Judge stood down or adjourned the case after the 2-day scheduled hearing had run its course but with a view to re-convene as soon as possible when FEBC could then proceed make its "no case to answer" submission if LBPC's "mistaken" close could not be retracted. LBPC was directed by the District Judge to inform him if LBPC's attempt in the meantime to transfer the case to the High Court or to reach an amicable settlement with FEBC was successful so that the District Court need not re-convene.
- July 31, 2014LBPC through their lawyers wrote to FEBC a<br/>conciliatory letter proposing an amicable settlement.<br/>They said that it is "in the best interests of both parties<br/>to fully focus on their respective ministries as they<br/>move on from all past differences and grievances in

an amicable manner that sets the right tone for the implementation of the new Scheme".

- August 4, 2014LBPC through their lawyers wrote to FEBC<br/>threatening to transfer the proceedings of their suit<br/>from the State Court to the High Court to sue for<br/>\$615,000 if FEBC should choose not to settle.
- August 8, 2014FEBC lawyers replied to LBPC's lawyers to<br/>underscore that their action was totally devoid of<br/>legal basis. In order to avoid further legal costs for<br/>both sides, FEBC decided to offer LBPC a settlement<br/>sum of \$300,000 out of Christian charity.
- August 8, 2014 LBPC filed an application to transfer the suit to the High Court (OS 764/2014). This was done without the consent of the Attorney-General.
- August 14, 2014 LBPC wrote to accept FEBC's offer of settlement.
- November 27, 2014 Justice Judith Prakash of the High Court finally issued the "Scheme for the Shared Usage of Nos 9, 9A and 10 Gilstead Road, Singapore".
- December 17, 2014 LBPC paid FEBC \$75,000 for costs in respect of the Court of Appeal proceedings (Civil Appeal No. 126 of 2010 hearing appeal on Suit 648 of 2008/J consolidated with Suit 278 of 2009 (started as Originating Summons 6 of 2009)). (LBPC had earlier in 2011 paid FEBC \$188,519 for costs and disbursements in respect of the High Court trial below.)
- January 4, 2015 Rev Charles Seet's article in the LBPC Weekly entitled "Live at Peace with All Men" called on Lifers to coexist peaceably with FEBC quoting Romans 12:17-18.
- January 4 2015 Rev Dr Jeffrey Khoo in the True Life BPC Weekly

in his report on FEBC entitled "FEBC Begins a New Chapter" wrote, "We pray for peaceful co-existence with Life BPC for the sake of the gospel and the testimony of Jesus Christ. We believe the Bible is 100% inspired and preserved in the Traditional Hebrew and Received Greek Texts underlying the good old Authorised Version (KJV). This is according to God's power in history and God's promise in Scripture (Ps 12:6-7, Matt 5:18).

- January 6, 2015 Settlement Deed to settle DC Suit 1956 of 2013/R signed and delivered.
- January 21, 2015 LBPC filed a notice of discontinuance for their suit (DC Suit 1956 of 2013/R) against FEBC.

#### Far Eastern Bible College Raised of God

I speak as an "honorary member" of FEBC (having served as President 1976-88).

When Brother Timothy called me to sit on the committee of a proposed Bible College, he had indeed planted a "*mustard seed*" which has grown into a great tree – an extension of God's Kingdom in the Far East.

In 1962, the College – FEBC – took shape in brick and mortar, to become part of God's divine plan for the last days, with roots tracing back to God's servants William Chalmers Burns (Scottish revivalist and missionary to South China) and John Sung, revivalist of the "Asian Awakening" of the 1930s. Without a doubt, these two servants of God had made deep imprints in Timothy's mind. That began the ministry of Far Eastern Bible College, a global institution set to "earnestly contend for the faith which was once delivered unto the saints" (Jude 3).

FEBC is an oasis in a world that is in the throes of spiritual drought and famine. Here, college students from all parts of the world imbibe the highest learning of all – in the words of the late Founder-Principal, "*the study of God and man – to know God and to know yourself is the true knowledge.*" (John Calvin).

FEBC was raised an instrument of God "for such a time as this"- to stand in the gap against the rising tide of unbelief and "falling away" (2 Thess 2:3) which is soon to engulf the world. In recent years we have witnessed the enemy sweeping in "like a flood," but with the B-P banner already lifted up and flying high.

FEBC is a "College of the Reformation and its Bible" – the KJV, the most faithful English translation of God's inspired, inerrant and infallible Word. At FEBC, students "Study to shew (themselves) approved unto God, (workmen) that needeth not to be ashamed, rightly dividing the word of truth" (2 Tim 2:15). FEBC trains students for service for God's everlasting

Kingdom, equipping men and women for the world's mission field, as SAFTI prepares soldiers for Singapore's armed forces.

FEBC, by God's enabling, extended its ministry of instruction in the Word of God by offering night classes, and on-line theological instruction: (1) <u>FEBC night classes</u>: This area of ministry is after the genius of the late Founder who filled two *"week nights"* with eager students from our own B-P churches and other churches in Singapore. These classes attract hundreds of hungry souls coming to be fed with the Bread of life. (Classes are held Monday and Thursday nights.). (2) <u>On-line instruction</u>: This *"on-line"* offer has made FEBC's courses of theological instruction a popular and convenient facility, readily accessible to students near and far, with growing numbers of on-line students from Singapore and overseas (in particular Perth and Melbourne, Australia) using this Gospel extension.

Ever conscious of our God-given mandate to be witnesses "*unto the uttermost part of the earth*" (Acts 1:8), FEBC has encouraged and helped her graduates to start Bible Colleges and similar institutions in their home countries. Over the years, these have sprouted up in Australia, Myanmar, Thailand, Vietnam, Cambodia, the Philippines, Indonesia and some African countries: Kenya, Tanzania, Rwanda and Ethiopia.

FEBC has proved itself faithful, truly raised of God for such a time as this, the last of the last days – a banner to witness against the upsurge of satanic forces of Ecumenism, Humanism, and One Worldism. God only is our help: to Him be all honour and glory.

A final and closing word to readers of like mind: stand fast, quit ye like men in this closing hour of world history, that we may hear the returning King of Kings and Lord of Lords say: *"Well done, thou good and faithful servant: .. enter thou into the joy of thy lord."* Amen.

My daily prayer is that the Spirit will keep FEBC always steadfast for "... the word of God, and for the testimony of Jesus Christ" (Rev 1:9). Amen.

# **The Sovereignty of God** Rev Errol D Stone Pastor, Faith Presbyterian Church, Perth, Australia

I am thankful to the Lord for being an alumnus of my Alma Mater the Far Eastern Bible College (FEBC) in Singapore which is a Beacon (Isa 30:17, 33:23, Ezek 27:5) even a Lighthouse that points out dangers and hazards (2 Cor 6:14-7:1) to the lives of Christians and shines forth in Asia and throughout the world under the Sovereignty of God. The FEBC was founded, as was the Bible-Presbyterian Church movement in Southeast Asia, by the late Rev Dr Timothy Tow, and is not only one of the oldest Bible Colleges in Singapore, but one of the very few Bible Colleges that have remained faithful (Jude 3) to God`s inspired, inerrant, infallible, faithful and perfectly preserved Word.

Throughout the 59-year faithful ministry of Rev Dr Timothy Tow, he was more than doubly blessed. In the Sermon on the Mount which is considered by the secular world as the greatest speech ever given, Jesus Christ gave the Beatitudes (blessings). Not only do the initial seven Beatitudes (blessings) apply to the founding principal of FEBC, but so do the remaining two, followed by the rejoicing which says: "Blessed are they which are persecuted for righteousness' sake: for theirs is the kingdom of heaven. Blessed are ye, when men shall revile you, and persecute you, and shall say all manner of evil against you falsely, for my sake. Rejoice, and be exceeding glad: for great is your reward in heaven: for so persecuted they the prophets which were before you." (Matt 5:10-12).

The FEBC is possibly the only Bible College in the world whereby the lecturers take the "Dean Burgon Oath," as they declare that God's Word is both verbally and plenarily inspired (VPI) (Matt 5:18, 2 Tim 3:16, 2 Pet 1:19-21) and verbally and plenarily preserved (VPP) (Ps 12:6-7, 119:152, Prov 22:20-21, 30:5-6, Isa 40:8, Matt 4:4, 5:18, 24:35, John 10:35, 1 Pet 1:22-25). By taking the oath, lecturers understand the faithfulness of the King James Bible/Authorised Version and have a "High View" of God's Word which delineates its lecturers, as opposed to a "low view".

In its original faithfulness, the International Council of Christian Churches (ICCC) which was established in Amsterdam in 1948 to stand against the World Council of Churches (WCC) understood the doctrine of VPP which is a necessary corollary of the VPI.

It was by the Grace and the Sovereignty of God that the FEBC was not destroyed when forced through the legal system because of its stance upon the VPP. Not only was the truth of the doctrine confirmed by certain Judges of the Singapore legal system as coming from the Westminster Confession of Faith, it is also most importantly declared by God's Word and understood by those who study it in truth. By the grace of God the boundaries (ancient landmarks) were protected from fraudulent shifting (Deut 19:14; 27:17, Job 24:2, Prov 22:28; 23:10; Hos 5:10).

God's Word says, "Vengeance belongeth unto me, I will recompense, saith the Lord" (Heb 10:30, Deut 32:35). As the jealousy of Joseph's brothers caused hatred towards him and they meant it for bad, God meant it for good (Gen 50:20). As FEBC endured the opposing pride and bitterness of hearts (Isa 64:6, Jer 17:9), the doctrine of VPP was further delineated and clarified by Rev Dr Jeffrey Khoo (the current FEBC Principal) and fellow lecturers. This was used for good for the furtherance of the Gospel truth (Phil 1:12) under the Sovereignty of God.

# Unflinching and Uncompromising Rev Stephen Khoo Lecturer in Biblical Studies, Far Eastern Bible College

I joined FEBC as a student in 1980 when I was 42 years old and graduated in 1985. It was initially a struggle for me, considering my age, to return to studies. But I thank my Saviour, the Lord Jesus Christ, for His sustaining grace. It was a great privilege to have been accepted by the College to pursue a course in Theology.

It was only after further studies at Grace Theological Seminary in America that I appreciated my studies in FEBC. I had a solid and sound grounding of the Word at FEBC which helped me during my time at Grace. # **God Watched Over FEBC** Wee Hian Kok Director, Far Eastern Bible College

"But call to remembrance the former days, in which, after ye were illuminated, ye endured a great fight of afflictions." (Heb 10:32)

This was my experience in the past decade at FEBC. Thank God that He blessed FEBC, and FEBC prevailed.

My association with FEBC started in 1990. From its beginning, it had a close symbiotic relationship with Life Bible-Presbyterian Church. The leaderships of both were fervently supporting the late Rev Timothy Tow, the founding pastor of Life BPC and the founding principal of FEBC. In the decade of the 1990s, a lot of resources in terms of manpower and money went into expanding God's work in ASEAN (Southeast Asian countries). Bible schools and colleges were set up in Cambodia, and assistance was given to the Hilltop ministry in the Philippines, and in Myanmar.

But at the turn of the century, Rev Tow's leadership in the church was challenged, and the teaching of the Verbal Plenary Preservation of God's Word by FEBC was opposed. In 2003, Rev Tow felt he had no alternative but to resign from the pastorship of Life BPC. The relationship between Life BPC and FEBC deteriorated. Eventually the leadership of Life BPC tried to evict FEBC with a lawsuit in September 2008. Thank God that they failed. They failed because God judged.

As Dr Khoo had written in the True Life BPC Weekly of 15 March 2015, "The apex court on 26 April 2011 judged that FEBC has rights to 9, 9A, and 10 Gilstead Road and declared that 'the College, in adopting the VPP doctrine, has not deviated from the fundamental principles which guide and inform the work of the College right from its inception, and as expressed in the Westminster Confession ... It is not inconsistent for a Christian who believes fully in the principles contained within the Westminster Confession (and the VPI doctrine) to also subscribe to the VPP doctrine."

It was not an easy decade for FEBC. Our founding principal went home to be with the Lord. Two lawsuits were filed against us. But it was a necessary fight, for it was to defend the Word of God. Rev Timothy Tow knew that FEBC would face numerous attacks as it upheld God's Word. Remember the last stanza of the FEBC Anthem,

> If you unflinching wield the Sword; With loyal heart join in the fray, And fight till dawning of the Day!

We indeed thank God that He watched over FEBC throughout. Praise be to God.

#### **Trusting and Relying Upon the Lord!**

Forty graduation ceremonies is not a small achievement, thanks to God's faithfulness. The LORD who planted FEBC fifty years ago looked after this School of Prophets and gave her the increase! The five years that I spent in FEBC for theological studies were the best years of my life. His reply was, "Brother, sleep less. There is no other way." Looking back, I thank God that the training was hard. I learned to be disciplined and industrious – qualities that a young preacher must pick up because in the ministry the work abounds; bulletins, visitations, Bible studies and sermons must be done every week!

Indeed, FEBC is a memorial of God's goodness. Like a mustard seed, it was of a humble beginning. But the LORD blessed her with scores of people who love and care for her. These are the lecturers and tutors who commit themselves to equip the students; the board of directors who oversees her; the dedicated staff who give their lives to serve behind the scene; the students who keep the surroundings neat and clean; the "privileged few" who help the matron, Mrs Ivy Tow, in the kitchen; the benefactors who give their substance cheerfully; and the prayer warriors who intercede for FEBC daily. > Making Sense of Invoking God to Annihilate Far Eastern Bible College Elder Han Soon Juan

I am no theologian, but trying to be as detached as I possibly

could, I still cannot fathom why the Board of Elders (BOE) of Life Bible-Presbyterian Church (LBPC) could be so full of hatred for the Far Eastern Bible College (FEBC). I humbly submit that, however I look at it, my conscience and common sense tell me that their failed attempt to evict FEBC from its birth place is wrong and that it goes against the Holy Will of God simply because FEBC still trains workers for the Lord's Vineyard to proclaim and defend His Holy Word.

What 'unpardonable sin' has FEBC committed which justifies its eviction from Gilstead Road? Our only transgression is that we believe that we still have the perfect Bible preserved to the jot and tittle (Ps 12:6-7, Matt 5:18, 24:35) today. Like us, members of the BOE of LBPC also declare that the KJV is the very Word of God. As such, they should agree that the Bible in the original Hebrew and Greek underlying the KJV must similarly be the very Word of God! Incredibly, precisely because of our belief, they accused us of being heretics, who historically were branded criminals to be ex-communicated and burned at the stake. In short, they usurped the power of God to damn us to hell!

On 15 September 2008, LBPC filed a lawsuit to evict FEBC, claiming that they did not infringe on 1 Corinthians 6:1-8 because FEBC had indicated in July 2008 that it would seek a declaration from the High Court with regard to her rights to the premises at Gilstead Road. In light of FEBC being threatened to vacate the premises by 30 June 2008 or being deemed a 'trespasser', what would LBPC have expected FEBC do? Vacate the premises without seeking the determination of the Court, an institution ordained of God and eminently placed to do so? Certainly we did not break God's injunction in 1 Corinthians 6:1-8 as it was LBPC which commenced legal action against FEBC first as FEBC obtained the consent of the Attorney-General only on 8 October 2008 to bring its case to the Court, which FEBC duly did in January 2009.

I fail to understand how audacious and foolhardy the members of the BOE could be for having absolutely no fear of God in His command: "Dare any of you, having a matter against another, go to law before the unjust, and not before the saints?" (1 Cor 6:1) Not only did they take upon themselves, acting presumptuously without any care for the Word of God, but they even endeavoured to justify their action for going to law "before unbelievers" (1 Cor 6:6). Granted that, should they erroneously but sincerely believe that FEBC was instituting legal action against LBPC to its detriment, they should have known that two 'wrongs' did not make one 'right'! Also, that did not make it biblical for them to ignore God's warning in 1 Corinthians 6:1-8! Ironically, they even invoked God by holding daily prayer meetings for the duration of the Court Sessions that He should obliterate His own work at FEBC, preparing labourers for the harvest field! Obviously, they prayed amiss; praying outside the Will of God, beseeching Him to go against Himself!

As mortals, we may not know the end from the beginning, but praise the Lord, the Word of God declares in Isaiah 46:9-10: "I am God, and there is none else; I am God, and there is none like me, declaring the end from the beginning, and from ancient times the things that are not vet done, saying, My counsel shall stand, and I will do all my pleasure." And we take comfort because we know that "the afflicted people thou wilt save: but thine eyes are upon the haughty, that thou mayest bring them down" (2 Sam 22:28). We do not wish ill to our tormentors who have been bent on making enemies of us. Whatever it is, since "only by pride cometh contention", we, the "well advised" (Prov 13:10) will humbly let the proclamation of the Holy Word of God take its course. And we do well to be imbued with the godliness of American lawyer Horatio Spafford (reminding us of Job) who tragically lost his only son and all his real estate investments in 1871 and his five daughters two years later. In the midst of his sorrow, he penned the words to the hymn "It Is Well with My Soul". Indeed, we know from His Holy Word that it will be well with FEBC! All praise and glory be unto Almighty God!

#### Lessons in the Battle for the Perfectly Preserved Bible

As a fresh FEBC student in 2004, I found myself in the midst of the battle for the perfectly preserved Bible. I listened intently to the debate, knowing that God would surely ensure the preservation of His Word, for nothing is impossible with God. I made up my mind to find out more about how God preserved His Bible. I felt that I had much to learn and God had given this opportune time to learn as much as I can.

Thus I chose as my thesis the subject of demonstrating how God had preserved His Word from the earliest times, continuously till today in the texts underlying the King James Bible. This entailed much research work, reading the best godly minds who wrote on this subject. We were dealing with brethren but brethren who disagreed with us. It was important to be Christ-like in all our dealings with those who do not see eye to eye with us. I must not sin even when I am defending the Word of God. Later I heard from a sister who testified that she came out of a non-VPP church to join a VPP church because doctrine was important to her. She was most disappointed when she found members in the VPP church were behaving worse than her previous church. Though every church has its mixed multitude, the point is that with right doctrine there must be godly living.

The other memorable experience was the intensity of our prayers. How we prayed and cried unto the Lord to intervene and show us His loving favour as we felt that we were pushed around. This was especially so when the Life Church sanctuary was not made available to us. We prayed without ceasing. At every morning devotion, every Chapel Hour, every lecture and every group meeting in the dormitories, prayers were offered up to the Lord for grace and mercy. The Lord seemed to test us as things got worse. A lawsuit was brought against FEBC. They wanted to evict us! They were removing the ancient landmarks. Those were very dark days for it ended with us losing the court case.

Then a miracle happened. We appealed and we won. God be magnified. He has given us the victory. "*The Lord hath done great things for us; whereof we are glad*" (Ps 126: 3).

God Works In Miraculous Ways Mrs Irene Lim English Tutor, Far Eastern Bible College

Over the last decade, the Far Eastern Bible College has been put through a traumatic roller-coaster experience. Triggered by disagreements over the VPP doctrine, the conflict between the College and Life B-P Church culminated in a lawsuit against the College. Our Board of Directors and Faculty members, having always been law-abiding, peace-loving believers, faced the lawsuit with trepidation but went in with God's assurances, "*Lo*, *I am with you alway....*" (Matt 28:20b) and "...*Fear not; I will help thee*" (Isa 41:13b); and He certainly did.

The news of the defeat at the initial round was devastating but it brought all who loved and believed in the College to their knees, seeking God's Will and direction for FEBC. It was a trying but blessed time as we humbly learnt to pray as never before.

Upon the decision to appeal to the highest court in Singapore, God's gracious intervention overturned the earlier judgment which resulted in FEBC not just being allowed to stay put but awarded the use of more space and access to all three premises. Words could not describe our joy and gratitude when we received the news. More so was the miraculous way He brought it about.

God demonstrated to us the precious lesson that our sovereign God does not need to depend on trained theologians or even experienced ministers to defend His Word and His Work. In an astounding turn of events, the Appeal Judges, all of whom were not theologically trained, were given clear and deep insights into the issues brought before them. Our witnesses had been instructed not to present theological arguments during the hearing, so God did not use them in this instance to speak for Him. Yet, when the judgment was delivered, the judges showed detailed and accurate understanding with regard to inspiration, preservation and even the Westminster Confession of Faith. They pointed out that FEBC had not deviated in its doctrines but has in fact been consistent in its teaching and beliefs.

With grateful hearts, we thank God for His gracious endowment of more space and facilities to the College. Students in the next academic semester will be able to do their work in a more spacious and better-planned library and more accommodation facilities means that the College can open her doors to more, even families, who want to be trained and equipped to serve our Lord. All praise and glory be to His Holy and Blessed Name.

It is also God's providence that I am one of the eyewitnesses to what had happened to FEBC and the opposition and persecutions Rev Dr Timothy Tow, Dr Jeffrey Khoo and the FEBC Board of Directors and Faculty suffered from Life BPC leaders who were against our faith in the perfect Word of God, inerrant, infallible, without any mistake, not only in the original Texts (Autographs) but also in the divinely preserved Texts (Apographs), even the Traditional Hebrew Text (Masoretic Text) and the Traditional Greek Text (Textus Receptus) underlying the King James Bible. Personally, I had loved and read God's Word, the Holy Bible, with much faith, thirst and hunger before reading a book that casts doubt on God's Word through textual criticism. It was miserable as I had to turn to so-called "scholarly" men and books! It was a great pain for me when in August 2003 I heard that Rev Tow had to resign from the office of Pastor of Life BPC that he had founded, loved, and laboured hard for her growth for the past 53 years! After that, we truly thanked God for opening a door for Rev Tow to found True Life BPC, starting with the FEBC Worship Service held at the RELC on the first Sunday of October 2003. We continued praying for FEBC every day, and how we thanked God when we could complete one semester after another until we graduated! The Lord always honours those who honour Him and His Word (1 Sam 2:30). Without God's grace, God's Word and the biblical training at FEBC, I would never be what I am today, and that is why I have loved FEBC and prayed for her. With the sound teaching and training at FEBC, especially the original languages of the Scriptures, I now turn to, depend on, trust in and submit to God and His Word alone, and not men and their words. All thanks, praise and glory be to the Lord alone!

After my graduation in 2004, also by God's providence, I was reunited with my family in Brisbane to start the ministry over there, but I have never forgotten FEBC my Alma Mater since then. Later it was my privilege to be adopted as True Life BPC's missionary preacher. Then, it was my great joy to come back to Singapore for my ordination by my beloved Principal Rev Tow and the FEBC Faculty at the FEBC's 32<sup>nd</sup> Graduation Service in May 2007. Praise the Lord for His grace and mercy!

Satan does not need to waste his time and energy to attack professing and compromising "Christians" and pastors, but he will spare no effort to attack faithful Christians and pastors who seriously believe and practise the Word of God to the jot and the tittle, and then faithfully teach it and preach it to others. It was a great pain for me again when I heard that Life BPC leaders sued FEBC to evict her from her birthplace and to take over FEBC with their own personnel and programmes in September 2008! However, we continued trusting in our good, faithful and sovereign God,

humbly and earnestly crying unto Him with prayers. Our faith was tested when Dr Jeffrey Khoo emailed and informed me that the verdict was in favour of Life BPC! During the court case, all True Life BPC and Life BPC leaders and members prayed to God fervently. Thus, whose prayers would God listen to? Thank God for His sufficient grace that we did not give up our faith in Him and His Word in our prayers for the Court Appeal, knowing that Life BPC's joy would not last long. And exactly, our faithful and sovereign God did hear His children's humble prayers and defend FEBC and grant FEBC the victory at the Court of Appeal in April 2011! And later, God granted FEBC another victory over Life BPC's lawsuit against FEBC concerning the financial issue and the usage of the premises. How glad and joyful I am with many thanks and praise to God for His help and deliverance of FEBC and for blessing FEBC all these years!

I shall continue upholding FEBC, my Alma Mater, in my prayers, knowing that the enemies of God's Truth, especially Satan, will not leave FEBC alone. May the Lord our God continue to be with FEBC, preserve her, bless her and use her to train faithful ministers of God's Truth as His faithful witnesses in these last days of compromise, ecumenism, deception and apostasy. May God strengthen and bless the FEBC Principal, Rev Dr Jeffrey Khoo, and the Board of Directors, the FEBC faculty and students, and faithful FEBC alumni around the world.

To the brethren who are looking for a faithful Bible College to attend, I would wholeheartedly and highly recommend the Far Eastern Bible College and pray that you will also enjoy the blessed time and days with sound and biblical teaching and training at FEBC as I did. Amen.

#### The Spiritual Battle Rages On

My journey with FEBC began on the 18 July 2005, when I enrolled as a student in the Bachelor of Theology programme. At that time, I had heard of some rumblings about the doctrinal controversy regarding the preservation of the Bible, but I was not fully aware of all that was going on. I simply knew that the Lord had called me to the full-time ministry, and the best place to receive a theological education was certainly the Far Eastern Bible College.

Within a few short months of my enrolment, my own church, Calvary Pandan Bible-Presbyterian Churh, was thrown into the deep end of the conflict, as a church member was disciplined for publicly distributing in church, right after the worship service, subversive material that questioned the perfection and preservation of the Bible. In the months that followed, I witnessed how my pastors were sued for "defamation" by this church member because they refused to compromise and remained steadfast upon the truth. I also saw with growing dismay how this issue caused a split within the Board of Elders, with Elders beginning to take sides, whether they were for or against the doctrine of the Verbal Plenary Preservation of God's Word.

I thank God that while all this was going on in church, my personal convictions on this doctrine was being formulated and strengthened in the classroom. I felt very privileged to be able to study subjects such as Systematic Theology I, Fundamentals of the Christian Faith and New Testament Introduction, all which had an extensive section on the present perfection of the Bible. Lesson after lesson, we were brought to the very words of God, and shown how it is beyond a shadow of doubt that God has certainly promised to preserve His Word, down to the very jot and tittle.

Over the next few years, we also witnessed how the troubles grew in the college as well. It began with little inconveniences, like Life Church preventing us from using the PA system in FEBC Hall, and we were not allowed to use the small field at Beulah house for our recreational activities. These were a "thorn in the side", but tolerable. Then more restrictions were decreed, such as disallowing our use of the main sanctuary for the night classes, forcing students to cram into the smaller FEBC Hall, with many having to sit outside the hall and outside the kitchen to listen to the lectures. Many of the structures to house the students were also taken down, along with the area behind the kitchen where we had our meals. Also, the threat of legal action grew, as numerous letters were exchanged, with allegations thrown at us. Life Church naming FEBC as heretics, and insisting that they were the owners of the premises and FEBC was a tenant who had outstayed her welcome.

Faced with the prospect of possible eviction from our home, the students rallied together and initiated a weekly Thursday morning prayer session. As a student body, we poured our petitions unto the Lord, not just in those sessions, but also privately, and each time we came together. The theory that we received in the classroom was being put to the test, as we too had a little taste of what it means to earnestly contend for the faith, and to be on the receiving end of the persecutions that followed. I learned much throughout this period from both my lecturers and my fellow students, and learnt what it meant to practically live by faith and obey God's Word, no matter what. We thank God that none of these things broke us, but instead strengthened our resolve to hold firm to our faith, and the truth of God's Word.

Day by day, we also saw how our dear founding principal, the late Rev Timothy Tow, grew weaker and weaker, his heart undoubtedly weighed down with grief and sorrow over the unjust and vindictive actions of the pastors and session of the church that he founded and nurtured. I thank God that in my first few semesters, I still had the blessed opportunity to take subjects offered by Rev Tow, and even travelled with him on his final Holy Land pilgrimage in 2006. He passed away peacefully in his sleep in April 2009, one month before I was due to graduate. It was a sad morning, but one that I remember vividly, as all the students were gathered to bid farewell to our teacher, principal, mentor and spiritual guide. Perhaps that was also God's grace for him, as he did not need to experience the painful process of the court case that followed. Through the lawsuit, and then the appeal that followed, God's will was done, and His truth was vindicated. I was in Perth ministering at BPCWA when I received a call from Rev Quek who informed me of the Court of Appeal's decision. We had won! FEBC would be allowed to stay. It was an indescribable joy, an overflowing of thanksgiving, an overwhelming desire to praise and glorify our Lord. The years of battle were now coming to a close, the end was in sight.

Today, I am still very much a student of FEBC. I thank God for the wonderful opportunity to both study and serve the Lord at the same time. It has been nearly 10 years since I first stepped foot into the college, as a young wide-eyed ignorant boy. I thank the Lord for the education that He has provided, and the experiences that I have gained. The four years spent there were priceless beyond rubies.

I know that although the battle has now come to a close, the war is certainly not over. The spiritual battle rages on, and we must always be prepared to hold forth the Word of God, and to stand firm against the many attacks of the evil one. My prayer is that we, the younger generation of full-time ministers, will remain steadfast and true, just as our forefathers have. We must never take the peace that we now have for granted, and never wane in our love and zeal for the Lord. Ten years may seem like a long time, but I know it is but the beginning. My prayer, and I hope you will pray the same for me, is that I will always remain faithful, and always seek to do only His will. Amen.

Even the proverbial saying: *"Remove not the ancient landmark, which thy fathers have set"* had a fresh meaning to us.

By God's leading, students in my batch experienced God's ultimate deliverance and the triumph of faith. God vindicated His Bible College just before we graduated from FEBC.

By God's leading, FEBC went through fire and water but God gave her an expected ending. Indeed, "they that trust in the LORD shall be as mount Zion, which cannot be removed, but abideth for ever." (Ps 125:1).

#### **Stressing the Academic and Practical Side of the Ministry**

It has now been more than 30 years since my relationship with FEBC commenced. I was introduced to FEBC by missionaries of The Independent Board for Presbyterian Foreign Missions (IBPFM) when I was a student at Bible College of East Africa. At that time, Rev Timothy Tow had come to Nairobi for the International Council for Christian Churches (ICCC) Congress. Subsequently, I applied to study at FEBC.

I came in January 1984 and undertook the BTh Course, and graduated in 1987. The main reason for my coming to FEBC was to be equipped to teach the Word of God. The Africa Gospel Unity Church where I minister was a young church with a handful of trained pastors. The long term plan for meeting this need was through the establishment of a school to train the pastors. FEBC was the right place for that training. At FEBC I learned to unlock the secrets of theology and developed proper discipline of studying and teaching the Word of God. At the Institute, the Lord has blessed our graduates and many of them are serving in the local churches here in Kenya. A number of our graduates have also come to FEBC to upgrade themselves. Jonathan Langat and Nelson Were are some of the alumni who had done well and are teaching with me at Bomet. The latest addition is Daniel Yaban.

I had no intention of coming back to FEBC until one of my friends came for a higher degree, since he was a little older than I was. Then I thought I could also attempt for a higher degree. I came to FEBC again in 2003 and graduated in 2004 and 2005 with MDiv and MTh respectively. All that I learned was worth it all.

It was at this time also that Rev Tow resigned as Pastor of Life BPC and started True Life. We had first-hand experience of the "controversy" about the VPP doctrine. We have since included this doctrine in our Institute's Statement of Faith. FEBC's current Principal Dr Jeffrey Khoo was instrumental in the defence of this doctrine and has written extensively on it. It is always true that all things work together for good to them that love God. The debate and the splits that the controversy has caused were not in vain as the importance of the VPP doctrine

has been highlighted. I read the Court of Appeal's judgement on the property issue and it was interesting that a public institution was able to interpret doctrine positively. Only the providence of God made this come to pass.

It is with great expectation that we look forward to a continuous association with our alma mater. Since 2005 Sister Carol Lee has become a visiting lecturer at BBI and we have received much of FEBC's teaching material. We will continue to uphold our School of Prophets before the Lord and pray His servants to serve faithfully.

What I had pictured in my mind was a Bible College that was like a university with grand facilities as seen in various countries. However, everything changed when the days and nights were spent to deepen my understanding and knowledge of God. FEBC hall had become a lovely

and exciting place as the Word of God was expounded daily (cf 2 Tim 2:15).

The Bible was the very foundation of all teaching and preaching in every class. A high view of Holy Scripture had been inculcated into every student (cf Matt 5:17-18; 24:34). The Bible is the only source of all truths for spiritual and practical living of every true believer in Christ Jesus (cf 1 Pet 1:25). All these happened because of his love for the Truth, the perfect and preserved Word of God (cf Matt 5:17-18; Ps 12:6-7). When FEBC lost the case, I pondered, "*O Lord, where should FEBC go? Would FEBC be closed for good?*" It seemed that it was the climax of the trial. God's servants ought to defend the truth. The Lord knew everything about FEBC and her future.

The lawsuit against FEBC was allowed by the Lord to take place with a purpose – that FEBC might grow from strength to strength and have faith in Him. ## The Burning Bush Defends, Educates and Informs

For these reasons, among many others, the journal is not only part of my library for reference in theological issues, it also gives updates regarding our beloved *Alma Mater*. It is therefore a rich piece of writing and I would not like to miss any issue. May God bless FEBC and the ministry of *The Burning Bush* as you celebrate God's faithfulness all these years.

It was a tumultuous time, but the lessons were invaluable. When Peter was imprisoned, prayer was made without ceasing by the church (Acts 12:5). In like fashion, FEBC students gathered to pray – and some even fasted. Never is one drawn to prayer in such a manner until one realises his own helplessness in a situation – when God is the only Helper. Yet sometimes, through the trials of others, God teaches us what it means to stand for the Truth. We saw lecturers – men of God – greatly scorned in the eyes of the world. # **College News**

**FEBC started its new term with a blessed day of prayer on Monday 5 January 2015.** We had a good attendance of over a hundred faculty, students and alumni. The principal spoke from Psalm 98 which is a psalm of joy and praise for God's protection and preservation of His people. With heartfelt gratitude to God, Matron Ivy Tow, shared about FEBC's beginnings and inaugural day of prayer back in September of 1962 when the Founding Principal, Rev Dr Timothy Tow, in a hall of "majestic emptiness" in the new premises read Psalm 34:10, "*The young lions do lack, and suffer hunger: but they that seek the LORD shall not want any good thing.*" The Lord is true to His promise. In a time of great distress when LBPC sued to evict us, Mrs Tow shared how the Lord comforted her with this verse, "*Ye shall not fear them: for the LORD your God he shall fight for you*" (Deut 3:22).

In the January-May 2015 semester, the College had a total enrolment of 605 students: 90 day students (fulltime: 50, part-time 40), 359 students in the "Basic Theology for Everyone" night classes, and 156 distance learning students. The students come from 11 countries: Australia, Cambodia, China, India, Indonesia, Korea, Kenya, Malaysia, Myanmar, the Philippines, and Singapore.

There were a total of nine new fulltime students: (1) Allan Tang Tuck Kong (Singapore), (2) Bae Myung Ho (Korea), (3) Chieng Yew Jinn (Australia), (4) Cing Sian Lian (Myanmar), (5) Elisabet (Indonesia), (6) Kim Yechan (Korea), (7) Lee Young Won (Korea), (8) Samuel Joseph (Singapore), and (9) Wang Shuai Yong (China). However, two from Korea, Bae and Lee, have decided not to pursue their studies here due to FEBC's premillennialism, and have since returned home.

The lecturers and courses taught last semester were as follows: The Rev Dr Jeffrey Khoo taught Systematic Theology IV (Eschatology), The Westminster Standards, Greek Exegesis II; Rev Dr Quek Suan Yew Old Testament History II, Revelation, Contemporary Theology II, Hebrew

Reading II; *Rev Dr Prabhudas Koshy* the Gospel of John, Homiletics, Hebrew Elementary II (assisted by Clement Chew); *Mrs Ivy Tow* Greek Elementary II; *Rev Stephen Khoo* Church Administration; *Rev Dr Koa Keng Woo* Bible Geography I, Cults I; *Rev Tan Kian Sing* Ephesians; *Mrs Jemima Khoo* The Christian School, Beginner Pianoforte; *Miss Carol Lee* Adult Christian Education, Thinking and Study Skills; *Mr Dennis Kabingue* Greek Reading II; *Mrs Anne Lim* English Intensive I; *Mrs Irene Lim* English Intermediate I; and *Elder Han Soon Juan* English Advanced I. The online courses offered were Calvin's Institutes II, Life of Christ I, and The Bible and Miracles.

The "Scheme for the Shared Usage of Nos 9, 9A and 10 Gilstead **Road, Singapore**" was issued by the High Court on 27 November 2014. The renovation and repair works at FEBC are underway. The L-Annex and Extension Blocks at 9A Gilstead Road already a half-century old need a lot of repairs. The dormitories which the Judge remarked as "spartan" will get a new lease of life. The corroded water and sewage pipes in the toilets need to be replaced. The pitched roof has been waterproofed. FEBC have rights to 10 Gilstead Road as well, in Beulah House and the New Beulah Centre (5-storey block) behind Beulah House. Beulah House was supposed to be built for FEBC. God is just to give us our share of Beulah House. The 2<sup>nd</sup> storey of Beulah House houses the FEBC offices and bookroom. The 2<sup>nd</sup> storey comes with high ceilings, coloured window panes, and wood flooring. It has a charming colonial and yet kampong feel to it. Hebrew, Greek, and English classes are now conducted at the New Beulah Centre (4<sup>th</sup> storey). We are also thankful for the additional living quarters at the 5<sup>th</sup> storey of the New Beulah Centre. "*The LORD is the portion of mine* inheritance and of my cup: thou maintainest my lot. The lines are fallen unto me in pleasant places; yea, I have a goodly heritage." (Ps 16:5-6).

The 2<sup>nd</sup> lawsuit (DC Suit No 1956/2013) filed by Life Bible-Presbyterian Church (LBPC) against FEBC was withdrawn on 21 January 2015 after LBPC proposed to settle out of court when the State Court hearings concluded in July 2014 with FEBC having no case to answer. (A no case to answer is the defendant's submission that the plaintiff has no evidence and no legal grounds to make a case for the defendant to rebut. A successful no-case submission results in the acquittal of the defendant.) Applying the biblical law of charity, FEBC offered Life BPC a sum of \$300,000. LBPC accepted it. The "Cost Apportionment Report for Life Bible-Presbyterian Church and Far Eastern Bible College at Nos 9, 9A and 10 Gilstead Road, Singapore," was completed by Jones Lang Lasalle on 25 March 2015. The main purpose of the Report was to review and address the cost apportioning of the maintenance and upkeep of the Premises including utilities charges currently occupied by both parties. The Report calculated that the College has exclusive use of 1811.88 sqm and the Church has exclusive use of 1999.72 sqm of the premises (ratio of 48% and 52% respectively).
